## Introductory Cover Letter to the Formal Letter

## To the Rt. Hon. Stephen Harper Prime Minister of Canada \*\*\*\*JULY 2010\*\*\*\*\* Title : The Public Exposure of Criminal Acts:

**Overview:** Criminal Acts Committed to Influence Federal Politicians, Federal Programs to Obstruct Justice, Violate Federal Mandates, and the Violation of the Charter of Rights and Freedoms : The Results, a Legally Defined Criminal Conspiracy. A Formal **Request for Documentation to Prove the Allegations** and bring Felony Fraud charges against Douglas Wright and the University of Waterloo. Dear Prime Minister Stephen Harper:

First , Sir, make no mistake , this is a very serious letter meant for the public domain, and will measure whether or not you support law and order, the public trust and safety ,and the Charter of Rights and Freedoms. My name is Edward A. Greenhalgh , and I expect to end a very regrettable affair with your help by ordering the release of federal materials so criminal proceedings and other may go forward. The over all material in the Formal Letter (accompanying) will be seen to be appropriate to send to the Prime Minister of Canada as it pertains to issues of national (and international) concern; such as the misuse of political power and privilege by influential individuals for a Criminal Conspiracy (legal definition), and the violation of federal programs that have direct relevance to medical research, its funding , and education; and the public safety.
